1. Purpose

As per the 2021 Asian Le Mans Series Sporting Regulations, certain aspects related to the application of the Series regulations -including technical regulations - have been entrusted to the Committee. The Committee is either named "Committee" or the "Asian Le Mans Series Committee" in the Sporting Regulations.

2. Composition

For the 2021 season, the composition of the Committee has been amended as follow:

- Thierry Bouvet
- Clément Hugon
- Cyrille Taesch Wahlen

3. Principle of operation

Any Competitor, manufacturer or driver wishing to obtain a clarification on a point of the regulations between two Competitions, may submit the matter to the Committee.

Any interpretation given by the Committee cannot be opposable to the sporting authority represented by the Race Director and the Panel of Stewards.

DECISION (CONTINUED)

To do so, the Competitor or driver must send the Committee a request, duly motivated, clearly specifying the points on which they are requesting an interpretation.

Any request shall be sent to comite.asian@lemans.org with copy to the Asian Le Mans Series Event Manager (c.ong@lemans.org).

4. Applicable regulations

The Committee may clarify or amend provisions of the regulations applicable to the Series. For the avoidance of doubt, these regulations are:

- 2021 Asian Le Mans Series Sporting Regulations
- 2021 Technical Regulations for LMP2 Prototype Homologated in 2017
- 2021 Technical Regulations for LMP3 Prototypes
- Applicable regulations - FIA GT3 cars
- Applicable regulations - GT Cup cars

5. Field of competence

The Committee is competent for, without its competence being limited to, the following matters, as described in the 2021 Asian Le Mans Series Sporting Regulations:

- Amend the Sporting Regulations (Art. 1.2.5) and applicable Technical Regulations
- Rule on car model change (Art. 3.6)
- Rule on the admissibility of innovative cars (Art. 6.1.7)
- Design and amend equivalence systems, including the BOP for GT3 cars (Art. 6.3)
- Amend provisions regarding tyres (Art. 6.5)
- Mandate and carry out checks pertaining to testing regulations (Art. 8)
